Basic information on the processing of personal data

## 1. Data controller

## 3. The purposes of processing and the legal basis for processing and the duration of processing.

Your data will be processed in order to carry out the services you have ordered, such as participation in light exhibitions, or implementation of the "Garden of Lights Newsletter" service, as well as in response to your contact with us (e.g., via contact form, email or telephone).

Processing time: until the performance of the services or request subject to the processing period necessary for the performance of legal obligations and the right to assert, exercise, defend possible claims.

## 4. Access data and hosting

You can access our websites without providing your information personal. For each web page call, the server automatically saves only so-called server logs, such as the name of the requested file, Your IP address, date and time of the call, amount of data transferred and The requesting ISP (access data) and documents the page call.

This data is analyzed solely for the purpose of ensuring the proper functioning of the site and improving our offerings. The above serves - as part of an interest assessment - to safeguard our legitimate interest in presenting our offer correctly. All access data is deleted within seven days of the end of your visit to the site.

#### 5. Hosting services provided by a third-party service provider

As part of the entrustment of data processing - on our behalf, an external service provider performs web hosting and presentation services for us. All data that - in the manner described in this privacy policy - have been collected in the use of our website or in the forms provided for this purpose, are stored on the servers of this service provider. Processing on other servers takes place only to the extent specified in this privacy policy. This service provider is based in a country belonging to the European Union or the European Economic Area.

#### 4. Data transfer

Your data may be transferred, for the purpose of contract performance, to entities that process personal data exclusively on behalf of Wonderful Lighting, with such entities processing data on the basis of a contract with Wonderful Lighting and exclusively in accordance with Wonderful Lighting's instructions.

Your data may be transferred to the following entities:

- payment platforms that cooperate with Wonderful Lighting to process online payments
- processors in connection with commissioned activities carried out by Wonderful Lighting on behalf of Wonderful Lighting
- law firms contracted by Wonderful Lighting, for example, to run the

- entities cooperating with Wonderful Lighting: Facebook, Google, Youtube, Google Analytics, which may place their own cookies (you can find information about external cookies on the websites of cooperating entities).

#### Transfer of data outside the European Economic Area

- Your data will not be transferred to recipients located in countries outside the European Economic Area.

#### 7. Rights of the data subject You have the right:

- access to your data

- lodge a complaint with the supervisory authority dealing with the protection of personal data.

#### 8. Voluntariness of providing data

We collect personal data only if you give it to us voluntarily provide by ordering a service, contacting us (e.g., via using the contact form or by email). We process data necessary for the performance of the contract or the handling of the case in which they contacted you.

#### 9. Data protection measures taken

Data protection is carried out in accordance with the requirements of common applicable laws, and their storage takes place on secured servers.

We respect the right to privacy and take care of data security. For this purpose, among other things, a secure communication encryption protocol (SSL) is used.

We have implemented data encryption and have access control in place so that we minimize the impact of any data security breach.

#### 10. Cookies

The [gardenswiatel.pl](http://gardenswiatel.pl) website uses cookies. These are small text files sent by a web server and stored by the browser's computer software. When the browser reconnects to the site, the site recognizes the type of device from which the user connects. The parameters allow only the server that created them to read the information they contain. Cookies thus facilitate the use of previously visited sites.

The information collected relates to IP address, type of browser used, language, type of operating system, ISP, time and date information, location, and information sent to the site through the contact form.

The data collected is used to monitor and see how users use our sites in order to improve the site by providing a more efficient and seamless navigation experience. We monitor user information using the Google Analytics tool, which records user behavior on the site. Cookies identify the user, allowing us to tailor the content of the site he or she uses to his or her needs. By remembering his or her preferences, it makes it possible to appropriately tailor advertisements directed to him or her. We use cookies to guarantee the highest standard of convenience on our site, and the collected data are used only internally by Wonderful Lighting to optimize operations.

We use the following cookies on our website:

"necessary" cookies to enable the use of services available on the site, such as authentication cookies used for services that require authentication on the site;

cookies used for security purposes, e.g. used to detect misuse of the site's authentication;

"performance" cookies, which enable the collection of information about the use of the website's pages;

"advertising" cookies, allowing to provide users with advertising content more tailored to their interests.
