#### I. DEFINITIONS

- 1) **Legendia** the theme park Legendia Śląskie Wesołe Miasteczko, located in Chorzów (41-501 Chorzów) at 1 Attraction Square, where the Exhibition is organized;
- 2) **Organizer** -WONDERFUL LIGHTING Spółka z ograniczoną odpowiedzialnością with its registered seat in Gdynia, 67 Architektów Street, 81-528 Gdynia, registered in the Register of Entrepreneurs of the National Court Register under KRS number: 0000614792, holding NIP: 9512412176 and REGON: 364312163;
- 3) Regulations these Rules of Order of the Exhibition;
- 4) **Exhibition** thematic outdoor installations, based on lighting techniques and educational and entertainment displays with the character of an illumination park.

#### II. GENERAL PROVISIONS

- 1. The exhibition is intended for cultural purposes. It can be visited individually.
- 2. There is a fee to use the Exhibition visitors to the Exhibition are required to purchase a valid admission ticket.
- 3. Rules related to ticket sales are provided for in the Exhibition Ticket Sales Regulations.
- 4. The exhibition is made to a standard that allows for safe visiting, as well as safe staying on the premises of Legendia, provided that the rules provided for in these Regulations are observed, subject to Section II. 7 of the Rules and Regulations and the rules and regulations of the attractions available that day in the Park.
- 5. The premises of Legendia are monitored, the purpose of data processing is to protect the rights and interests protected by law.
- 6. The Rules and Regulations of the Gen. Jerzy Ziętek Regional Park of Culture and Recreation S.A. in Chorzów, available at the Infocenter, at <a href="www.parkslaski.pl">www.parkslaski.pl</a> and at <a href="www.legendia.pl">www.legendia.pl</a> in the "Info" tab, are also in force on the Exhibition grounds. Legendia Regulations: Legendia Regulations of the Silesian Merry-Go-Round, Regulations of Organized Groups, Claims Regulations, Parking Regulations, Regulations of the GOPASS Program, Fastpass Regulations, Regulations of Attractions and Procedures.
- 7. During the Exhibition, visitors may be in the area of strong lighting including flashing lights, which may trigger an epileptic attack.
- 8. All persons in the Exhibition area are obliged to comply with these Regulations.
- 9. Entering the Exhibition area is tantamount to reading the Rules and Regulations and accepting them.
- 10. A thematic outdoor game is being organized in the exhibition area.

## **III. RESPONSIBILITY**

- 1. Adults residing in the Exhibition area are fully responsible for damages caused by their acts or omissions.
- 2. Children under the age of 12 may visit the Exhibition only under the supervision of adults who are fully responsible for the behavior and damage caused by the minor, with one adult allowed to look after no more than 10 minors.
- 3. The Organizer shall not be liable for accidents or injuries or any loss, including theft or damage to the property of visitors arising in connection with their stay in Legendia or visit to the Exhibition.
- 4. The organizer is not responsible for accidents and incidents caused by failure to comply with these Regulations, the Rules and Regulations of the Gen. Jerzy Ziętek Regional Park of Culture and Recreation in Chorzów, failure to comply with the rules of use of the facility, as well as general health and safety rules.

## IV. RULES FOR ENTERING THE GARDEN AND VISITING THE EXHIBITION

1. The exhibition is open:

- 1) Whereby public holidays are defined as public holidays and December 27, 2023,
- 2. The exhibition is closed on December 24, 2023, December 31, 2023.

December 28, 2023. and December 29, 2023;

- 3. Information about the days on which the Exhibition is closed is posted each time on the website: www.gardenoflights.pl. It is also possible to obtain them by phone at (+ 48) 459 595 777.
- 4. The Exhibition area is open to the public during the hours indicated above and on the websites <a href="www.gardenoflights.pl">www.gardenoflights.pl</a> and <a href="www.legendia.pl">www.legendia.pl</a>, social networks, information boards in front of the main entrance to Legendia and at the Infocenter. Outside of regular opening hours, access to the Exhibition area is possible only with proper permission.

- 5. The Organizer reserves the right to temporarily close or limit access to the Exhibition, in particular due to lighting failure, difficult weather conditions and other factors beyond the Organizer's control, about which he will inform on the website mentioned in point IV. 3. of the Regulations on its website.
- 6. In case of bad weather conditions, the opening hours of the Exhibition may be shortened. In accordance with the early closing procedure, Visitors will be informed by the staff and the park public address system.
- 7. Visitors to the exhibition have the opportunity to use selected entertainment devices located at Legendia. Information on the availability of individual devices is updated on Legendia's website, at Ticket Sales Points and at the Infocenter.
- 8. In the event of bad weather or force majeure, equipment that cannot operate under such conditions for safety reasons may be halted in operation until the bad weather or force majeure ceases. Suspension of operation of equipment due to force majeure shall not constitute grounds for refunding the value of tickets or any part thereof.
- 9. Legendia has procedures in place for dealing with accidents, early park closures and emergencies and are available at the Infocenter.
- 10. Entry and exit to Legendia is through gates activated by a paper ticket with a printed barcode, a digital card on a mobile device, or an RFID card issued as part of GOPASS participation.
- 11. Once you have left Legendia, you cannot re-enter the Park with the same ticket, except in emergencies by arrangement with Infocenter staff.
- 12. Entrance to the Exhibition area is possible no later than 30 minutes before its closing. Regardless of the time of entry, it is possible to stay in the Exhibition area until its closing.
- 13. People with disabilities and pregnant women are served out of turn.
- 14. The staff of the Exhibition, the Legendia and the mobile security patrol are authorized to control the possession of a valid ticket of admission to the Legendia, and Guests of the Exhibition are obliged to show it at their every request.
- 15. It is prohibited to enter the Exhibition area:
  - 1) Bringing in hazardous materials and objects, in particular, such as:
    - a. Guns, firearms and other devices that fire projectiles;
    - b. stun devices;
    - c. objects with a sharp end or sharp edge;
    - d. glass bottles;
    - e. working tools;
    - f. blunt instruments;
    - g. explosives and incendiary substances and devices;
    - h. Radioactive or oxidizing substances, bleaching agents;
    - Poisonous agents such as insecticidal sprays, infectious or environmentally hazardous substances;
    - j. corrosive materials and liquids;
    - k. sprays for self-defense;
  - 2) Bringing in food, beverages, especially alcoholic beverages, intoxicants and psychotropic substances;
  - 3) Bringing in objects that may disturb the peace or cause any danger to others;

- 4) Use of drones and flying models without prior approval;
- 5) introduction and bringing of animals, while this prohibition does not apply to authorized persons with a guide dog;
- 6) Behavior that is disruptive and dangerous to other visitors;
- 7) Crossing fences and entering areas that are off-limits to visitors.
- 16. The Organizer reserves the right to inspect items and substances brought into the Exhibition area.
- 17. The Organizer is not responsible for items left by Guests in the Exhibition area.
- 18. The sale and consumption of alcoholic beverages is allowed only in places intended for this purpose, i.e. catering facilities, gardens and terraces adjacent to them, which, based on the approval of the competent administrative authority, have obtained permission for its sale.
- 19. The right to refuse entry to the Exhibition grounds exists in situations:
  - 1) When a person's behavior poses a threat to public order or the safety of others.
  - 2) When the person wishing to enter the Exhibition area is under the influence of alcohol or other intoxicants;
  - 3) when the person wishing to enter the Exhibition grounds is under 12 years of age and intends to visit the exhibition without a guardian;
  - 4) When a person wishing to enter the Exhibition area attempts to bring in prohibited items or animals;
  - 5) when the person wishing to enter the Exhibition grounds has violated the rules and regulations of the season ticket and the T&Cs of the Gopass program.
    - Refusal of admission to the Exhibition in connection with the above-mentioned cases does not entitle to a refund of the value of the admission ticket purchased, its part or any other form of compensation.
- 20. Persons in the Exhibition area are required to behave in a manner that does not endanger the safety of others.
- 21. Any Visitor with a valid admission ticket may enter the Exhibition, Legends or segregated
- 22. No person under the influence of strong alcoholic intoxication or intoxicants or psychoactive substances is allowed on the Exhibition grounds. In case of doubts about the state of the visitor, the decision is made by the Organizer or a person authorized by him.
- 23. Only pedestrian traffic and wheelchairs and baby carriages, as well as electric vehicles of the Park or Exhibition service melex type are allowed in the Exhibition area.
- 24. Persons staying in the Exhibition area are obliged to:
  - 1) maintaining cleanliness;
  - 2) respecting the greenery and property located on Legendia's premises;
  - 3) comply with the instructions and remarks of the Organizer and persons authorized by the Organizer, including employees of the Exhibition and Legends.
- 25. In particular, it is not allowed in the Exhibition area:
  - 1) Disturbing the peace and quiet, as well as using their own sound equipment;
  - 2) Pollution and littering of the Legendia area;
  - 3) Destruction of vegetation, lawns, flower beds, breaking trees and shrubs,
  - 4) Burning bonfires and leaving burning objects;
  - 5) Pollution and destruction of small architecture (benches, baskets, etc.);

- 6) staying in the park during the occurrence of force majeure threatening the health and life of the visitor to the Exhibition (you must comply with the instructions of the Organizer or a person designated by him);
- 7) Navigating on off-limits and/or icy alleys;
- 8) Consumption of one's own alcohol (with the exception of products purchased on the Exhibition grounds in the indicated places), use of intoxicants and psychotropic substances;
- 9) touching exhibits of the Exhibition, except those intended for direct interaction and marked as photopoints;
- 10) Entering fenced-off areas;
- 11) taking the elements of the Exhibition outside the Legendia area;
- 12) introduction and riding of bicycles, scooters, rollerblades, roller skates, skateboards, scooters or other similar means of personal transportation.
- 26. Smoking of tobacco products and electronic cigarettes is allowed only in designated areas. Smoking is prohibited in food service areas, restrooms, waiting areas and attractions

## V. PHOTOGRAPHY AND IMAGE

- 1. Each person, entering the Exhibition area, agrees to the use of his/her image, both his/her own and that of the children in his/her care, in case of video recording and photographing of the Exhibition by the Organizer (or persons authorized by it). The above also includes permission for the said video or photographic materials to be used by the Organizer in all productions, presentations, advertisements, reports - internal and external, without time and location limitations. The publication of the image of the Exhibition participants serves to popularize the Exhibition and promote the business activities conducted by the Organizer. Photographs and films are taken in a spontaneous manner by photographers/cameramen, who do not have the possibility of selective documentation, as they focus on interesting shots regardless of the person. The dissemination of the image is based on the permission of the photographed or filmed person, as mentioned in Article 81, paragraph 1, sentence 1 of the Law on Copyright and Related Rights. Permission to disseminate an image is a statement of intent expressed within the meaning of Article 60 of the Civil Code. A statement of intent - permission to disseminate an image cannot be freely revoked after the expression and realization of the recording / photo, since according to Article 61 § 1, sentence 2 of the Civil Code, revocation of the statement is effective if it occurred simultaneously with the statement or earlier. The processing of personal data (image of the Exhibition participant) in the light of the RODO is based on Article 6(1)(f) of the RODO, according to which: processing is lawful when it is necessary for the purposes of legitimate interests pursued by the controller or by a third party. The organizer has a fully legitimate interest to popularize the exhibitions it creates, including through video and photographic coverage of the exhibitions.
- 2. Free photography and/or filming for private use is allowed during the Exhibition tour.
- 3. The taking of photo shoots, both occasional and commercial, as well as the recording of video footage, is subject to a fee and requires appropriate permission.
- 4. Visitors to the Exhibition are prohibited from conducting any commercial, advertising, promotional or solicitation activities, as well as cash collections.

## **VI. FINAL PROVISIONS**

- 1. In case of violation of these Regulations by a visitor, the Organizer or persons authorized by the Organizer shall first draw the attention of that person, and in case of further non-compliance with the Regulations by that person, they shall have the right to expel that person from the Legendia premises.
- 2. In the case referred to in Section VI. 1 of the Regulations, the visitor shall not be entitled to any compensation, including reimbursement of ticket and other fees. The Organizer shall have the right to charge such a person with the costs incurred by him, in particular the costs of damages, liquidated damages, repairs and cleaning, resulting from violation of prohibitions or failure to comply with the requirements provided for in the Regulations.
- Possession of a valid ticket entitles the holder to stay and use the equipment and attractions located exclusively on the Exhibition grounds and does not authorize the holder to conduct independent sales activities without the prior written consent of the Organizer and Silesian Merry Town Ltd.
- 4. Commercial activity in the Exhibition area or in the area subordinate to Śląskie Wesołe Miasteczko Sp. z o.o. may be carried out only and exclusively on the basis of written consent of the Organizer and Śląskie Wesołe Miasteczko Sp. z o.o., otherwise a fine of PLN 5,000.00 will be charged each time.
- 5. In the event of non-compliance with the instructions of the Exhibition staff and in the event of gross violation of the rules and regulations, the Exhibition Organizer or persons authorized by him, have the right to summon law enforcement services, including the police.
- 6. These Rules and Regulations are available on the website: www.gardenoflights.pl, on the Legends website <a href="www.legendia.pl">www.legendia.pl</a> and have been posted in the form of information boards at the entrance to the Exhibition area.
- 7. The Organizer reserves the right to amend these Regulations.
