RULES AND REGULATIONS EXHIBITION "ALICE IN WONDERLAND" DEFINED BY

WONDERFUL LIGHTING LIMITED LIABILITY COMPANY HEADQUARTERED IN GDYNIA

I.DEFINITIONS

- 1. **Garden of Lights**: PAN Botanical Garden located in Powsin (02-973 Powsin) at Prawdziwka 2 street, 02-973, Powsin, where the Exhibition is organized;
- 2. **Organizer**: WONDERFUL LIGHTING Sp. z o.o., headquartered in Gdynia at Al. Zwycięstwa 96/98, 81-451 Gdynia, registered in the National Court Register under the number KRS: 0000614792, with NIP: 9512412176 and REGON: 364312163;
- 3. **Regulations**: these Rules and Regulations of the Exhibition;
- 4. **Exhibition**: themed outdoor installations based on lighting techniques and educational-entertainment exhibitions in the form of an illuminated park.

II.GENERAL PROVISIONS

- 1. The Exhibition is intended for cultural purposes and can be visited individually.
- 2. In principle, admission to the Exhibition is paid visitors are required to purchase a valid entry ticket.
- 3. The terms and conditions related to ticket sales are provided in the Ticket Sales Regulations for the Exhibition.
- 4. The Exhibition is constructed in a way that ensures safe viewing and staying in the Park, provided the rules specified in these Regulations are followed, with the exception of section II.5 of the Regulations.
- 5. During the Exhibition, visitors may be exposed to strong lighting, including flashing lights, which may trigger epileptic seizures.
- 6. All individuals on the Exhibition grounds are required to comply with these Regulations.
- 7. Entry to the Exhibition grounds constitutes acknowledgment of the content of the Regulations and acceptance thereof.
- 8. A themed outdoor game is organized on the Exhibition grounds.

III.LIABILITY

- 1. Visitors to the Exhibition are fully responsible for any damages caused by their actions.
- 2. Children under the age of 13 may visit the Exhibition only under the supervision of adults, who are fully responsible for their behavior and any damage caused by minors. One adult may supervise up to 10 minors.
- 3. The Organizer is not responsible for accidents, injuries, or any losses, including theft or property damage, incurred by visitors while being in the Park and/or visiting the Exhibition.
- 4. The Organizer is not liable for accidents and incidents caused by non-compliance with these Regulations or general health and safety principles.

IV.ENTRY AND VISITING RULES FOR THE GARDEN OF LIGHTS

1. The Exhibition is open:

- 1. Public holidays include legally recognized non-working days and additionally, December 27 and December 30, 2024, and January 2 and January 3, 2025.
- 2. The Exhibition is closed on December 24, 2024, and December 31, 2024.
- 3. Information about days when the Exhibition is closed is updated on the website: www.gardenoflights.pl. You can also obtain this information by calling: (+48) 459 595 777.
- 4. The Exhibition grounds are accessible to visitors during the hours mentioned above, as well as on the website www.gardenoflights.pl, social media platforms, and at the entrance to the Park. Outside regular opening hours, entry to the Exhibition grounds is only possible with proper authorization.
- 5. Visitors are required to comply with the opening hours and must leave the Garden of Lights before the gates close.
- 6. The Organizer reserves the right to temporarily close or restrict access to the Exhibition, especially due to lighting failures, adverse weather conditions, or other factors beyond the Organizer's control, which will be announced on the website listed in section IV.3 of the Regulations.
- 7. Visiting the Exhibition requires a purchased ticket. Visitors must carry the ticket with them and present it for inspection upon the request of Garden of Lights staff. The purchased ticket cannot be transferred to another person.
- 8. Entry to the Garden of Lights for visiting the Exhibition is possible no later than 30 minutes before closing. Regardless of the entry time, visitors may stay until the Exhibition closes.
- 9. Visitors may only move along designated paths and other areas open for viewing.
- 10. The following are prohibited on the Exhibition grounds:
 - 1) Bringing dangerous materials and objects, especially such as:
 - a. Guns, firearms, and other devices that shoot projectiles;
 - b. Stun devices;

- c. Sharp-pointed or edged objects;
- d. Glass bottles;
- e. Work tools;
- f. Blunt objects;
- g. Explosive materials, as well as flammable substances and devices;
- h. Radioactive substances or oxidizing agents, bleach;
- i. Toxic substances, such as insect sprays, infectious or environmentally harmful substances;
- j. Corrosive materials and liquids;
- k. Self-defense sprays;
- 2) Bringing food, drinks, especially alcoholic beverages, intoxicants, and psychotropic substances;
- 3) Bringing items that may disturb the peace (e.g., sports equipment, playing devices) or pose any threat to others;
- 4) Using drones or flying models;
- 5) Bringing and introducing animals (except for persons with a guide dog);
- 6) Engaging in physiological activities in undesignated areas (e.g., urinating);
- 7) Using vulgar language or engaging in behaviors that are bothersome to other visitors;
- 8) Crossing fences and entering areas closed off to visitors.
- 11. The Organizer reserves the right to inspect items and substances brought onto the Exhibition grounds.
- 12. The right to refuse entry to the Exhibition exists if a person's behavior poses a threat to public order or the safety of others.
- 13. Visitors on the Exhibition grounds are required to behave in a manner that does not endanger the safety of others.
- 14. Persons heavily intoxicated by alcohol or under the influence of intoxicants and/or psychoactive substances are not allowed on the Exhibition grounds. In case of doubt regarding a visitor's condition, the decision is made by the Organizer or an authorized person.
- 15. Only pedestrian traffic and the use of wheelchairs and strollers are permitted on the Exhibition grounds. Persons using wheelchairs or bicycles due to disabilities are required to present documentation confirming their disability.
- 16. Visitors on the Exhibition grounds are required to:
 - 1) Maintain cleanliness;
 - 2) Respect greenery and property located in the Park;
 - 3) Follow the instructions and remarks of the Organizer, staff, and employees of the Exhibition and Park.
- 2. The following activities are not allowed on the Exhibition grounds:
 - 1) Disturbing the peace and quiet, including the use of sound equipment;
 - 2) Polluting and littering the Park;
 - 3) Damaging vegetation, lawns, breaking trees and shrubs;
 - 4) Lighting fires and leaving burning objects (except for fire pits prepared by the Organizer);
 - 5) Polluting or damaging small architecture (benches, trash bins, etc.);
 - 6) Being in the park during storms and hurricanes;
 - 7) Walking on icy paths;

- 8) Consuming alcohol (except for products purchased on the Exhibition grounds), intoxicants, and psychotropic substances;
- 9) Smoking tobacco or using electronic cigarettes;
- 10) Touching Exhibition exhibits;
- 11) Entering fenced-off areas or areas closed to visitors;
- 12) Removing Exhibition elements from the Garden of Lights grounds;
- 13) Riding bicycles, scooters, roller skates, skateboards, or other similar individual transport devices;
- 14) Using closed areas and stations;
- 15) Using light installations in a manner inconsistent with their intended purpose, endangering the safety of visitors or creating the risk of station damage.
- 3. The sale and serving of alcoholic beverages is prohibited:
 - 1) To persons whose behavior indicates they are intoxicated;
 - 2) To persons under the age of 18. In case of doubt about the buyer's age, the seller or server of alcoholic beverages is entitled to request proof of age;
 - 3) On credit or in exchange for collateral.
- 4. Due to the type of surface present on the Botanical Gardens grounds (dirt paths, grass, artificial surfaces, sidewalks), trekking (hiking) shoes are recommended.

V.PHOTOGRAPHY AND IMAGE

- 1. Any person entering the Exhibition grounds consents to the use of their image, as well as the image of children under their care, in case the Organizer (or a person authorized by the Organizer) records videos and takes photos of the Exhibition. This also includes consent for these video or photographic materials to be used by the Organizer in any productions, presentations, advertisements, internal and external reports, without time or location restrictions. The publication of participants' images serves to promote the Exhibition and the Organizer's business activities.
- 2. Photos and films are taken spontaneously by photographers/cameramen, who do not have the ability to selectively document; instead, they focus on interesting shots regardless of the person. The dissemination of images is based on the permission of the person photographed or filmed, as referred to in Art. 81(1)(1) of the Copyright and Related Rights Act. Permission to disseminate the image is a declaration of intent expressed within the meaning of Art. 60

VI.FINAL PROVISIONS

- In the event that a visitor violates the rules of these Regulations, the Organizer or persons authorized by the Organizer will first address the individual. If the individual continues to disregard the provisions of the Regulations, they reserve the right to expel the person from the premises.
- 2. In the case mentioned in point VI.1 of the Regulations, the visitor is not entitled to any compensation, including refunds for the purchase of tickets or other fees. The Organizer reserves the right to charge the individual for any costs incurred, particularly compensation, contractual penalties, repairs, and cleaning, resulting from the violation of prohibitions or failure to comply with the requirements set forth in the Regulations.

- 3. If the individual fails to comply with the order to leave the Exhibition grounds, as referred to in point VI.1 of the Regulations, the Organizer and/or persons authorized by the Organizer have the right to call law enforcement services, including the police.
- 4. These Regulations are available on the website: www.gardenoflights.pl and have been posted as information boards at the entrance to the Exhibition grounds.
- 5. The Organizer reserves the right to amend these Regulations.
